Brooklyn Gastroenterology and Endoscopy PLLC Financial Policy

Brooklyn Gastroenterology and Endoscopy PLLC, is a for-profit Gastroenterology Office dedicated to providing gastroenterologists, anesthesiologists, pathologists, dieticians, psychotherapists and patients a safe and effective environment for the evaluation and treatment of diseases of the gastrointestinal tract. The office also provides the medical home for documentation and billing of procedures performed in The Greater New York Endoscopy Surgical Center as well as area hospitals for which doctors are affiliated. The office will bill professional fees for the work of the physicians of the group which may include pathology, anesthesiology and ultrasound. There may even be bills generated for the laboratory and ultrasound technical fees. All bills generated are only for work to be performed. If you feel that you are being billed falsely, you must contact the Medical Director, Dr. Tenner at 516-316-0830 or your insurance carrier.

Billing, payment, collection and participation with carriers may differ considerably between the facility and physician involved in the procedures at the facility. You are responsible to determine the benefits, copays and deductibles of your insurance. Our office will assist you if you request our office to determine the extent of your coverage and personal financial liability.

A professional attitude shall be used whenever communicating with patients and insurance companies regarding payment for services rendered. Appropriate staff will assure that the patient understands the implications of his insurance coverage, if any and the resulting personal financial obligation and responsibility for payment for services rendered.

As you know, the world of health insurance has become increasingly confusing and complex for patients and physicians alike. For this reason, we would like to bring to your attention that we are legally required to bill you for any applicable co-payments or co-insurance and/or deductibles which your insurance plan requires you to personally pay under the terms of your insurance policy according to the State of New York Insurance.

The Federal and State governmental agencies that oversee the health insurance industry have consistently taken the position that the routine waiver of co-payments and co-insurance by healthcare providers may constitute insurance fraud by the insured and the physician. Within 6 months of receiving a response from your carrier, you will receive a "balance bill". These amounts reflect that portion of our facility fees which were not paid by your insurance company and that remain as your personal responsibility. According to the State of New York Insurance Department, a decision in the exercise of business judgment by a physician not to pursue the full legal remedies available to collect a debt would not constitute insurance fraud. If payment of your full outstanding balance is not financially feasible for you at this time, please call our office and we will try to work out a mutually-agreeable payment plan that you can afford to pay over a reasonable period of time.

For patients who have a sizable financial obligation after payment by insurance, or for patients who have no insurance coverage, a payment contract or the use of a credit card may offer the opportunity to satisfy the financial obligation. For those patients wishing to satisfy their balance due via a financial agreement, the patient or responsible party will be required to sign a contract prior to the procedure. Patient or responsible party will be given a copy of the signed agreement, and the original will be maintained by the Accounts Receivable Office.
